Children with profound intellectual and multipe disabilities (PIMD) and their participation in family activities

Children with PIMD


Are heavily dependent on others (Nakken & Vlaskamp, 2002, 2007)

In Sweden, children with PIMD:

- Grow up at home together with their biological family
- Attend preschool and school (special classes)

A child's family is the most important part of the child's ecology (Bronfenbrenner, 1986; Dunst et al., 2001)

The child and the family



The social security system in Sweden gives possibilities for personal assistance for these children.



The overall purpose of personal assistance is to promote equality of living conditions and full participation in the society (the family included)


Parents as personal assistants

Hired external personal assistants

According to the child, the external personal assistant is also a part of his/her family (Wilder, 2008)

The child and the family



To find out about the role of the external personal assistant

Mixed method study including

- 60 questionnaires answered by parents of a child with PIMD
- 11 interviews with parents of a child with PIMD and 9 interviews with external personal assistants

Reinforcing role in relation to the child

A balancing role in relation to the family

= DUAL ROLES

Reinforcing role in relation to the child

- To substitue basic functions
- To support everyday life

- Relationship support
- To support maturation

"It is so wonderful, for the little girl, the two year old one, often asks about help: `please help me to tie my shoes' and then he [the older brother with PIMD] becomes very happy and helps his little sister with help of his assistant"...(parent)



Reinforcing role in relation to the child

- A high level of assistance needs to be given in the activities

"Yes, it really is a unique situation.
It is. You know that if the parents
or those people in that home had
been able to choose, then I
wouldn't be there. That's the way
it is, or, yes, since the situation is
the way it is, then it's a good thing
that I'm there, but it's not
something that anyone would
have chosen" (assistant 6)

A balancing role in relation to the family

A shared understanding

- Exhibit relational skills

- Fulfill the function

A balancing role in relation to the family

- E.g. do activities with the child outside the home

A balancing role in relation to the family

Conclusion

In planning and implementation of external assistance, the <u>child</u>'s needs as well as considerations of the whole <u>family</u> should be regarded

Discussions are needed about the personal assistant's role - in relation to the child as well as to the family

This in turn can help to achieve "stability" and sustainability desired in every family system
