Report on the Status of Elderly in Select States of India, 2011

- Self-rated health About 55 per cent rated their health as poor or fair
- Over five per cent suffer serious functionality issues with regard to basic functions, necessitating regular care and support
- 13 per cent reported an ailment in the 15 days prior to the survey (13 for F & 9 for M)
- Nearly two-thirds report suffering from at least one chronic ailment with arthritis, hypertension, diabetes, asthma and heart disease as the most commonly reported ailments

Report on the Status of Elderly in Select States of India, 2011



• Work participation rate:

- Males 39 per cent
- Female 11 per cent
- Majority of workers 60-69 age group
- Oldest old is also relatively high (13% men and 3% among women)
- Higher incidence of work participation among women living alone compared to those living with spouse or others
 About 80 per cent of the elderly co-reside with their spouse & children and in some cases with other relatives



Income insecurity, illiteracy, age related morbidity and physical and economic dependency are factors that tend to make the Indian elderly and particularly elderly women, vulnerable

Profile of caregivers

43% are sons

-63% are involved in business

21% are daughters 54% are homemakers with no earnings

- 16% are wives
 - -75% are homemakers with no earnings



Profile of caregivers

10% are husbands

Some run their own business and/or perform other occupation

- 7% are daughters-in-law
 - -70% are homemakers
- 2% are grandsons, sisters & sisters

-All are married with their children to care for



Caregiving under special circumstances

- Families remained the primary caregivers, no matter where their children lived
 - Widows are looked in the absence of children by grandchild, daughter-in-law and sister
- 44 years old daughter, separated from her husband and working as a Teacher with one child looks after her mother in law



Behaviour

- 65% experienced occasional aggression from Care Recipient
- 26% of CR sometimes exhibited uncooperative behavior while 65% never did so
 - Low burden levels of the Caregiver when the Care Recipient are less/least troublesome



Higher the number of long-term multiple diseases, more the need for trained caregivers

Seek assistance of twenty-four Trained Caregivers when Care Recipients suffer more than one health complication coupled with behavior problems



When an elderly care Recipient requires services that are more extensive than family members can offer, the provision of formal services at that stage cannot mean end informal services provided by the family members

Sons & daughters

Not hesitate incurring out-of-pocket expenditure to look after the elderly at home, be it parents or parent-in-law



Long distance caregivers economically support their elderly though their siblings



97% of the family caregivers maintain comfortable relationship with the Trained Caregiver Provider

Such a relationship benefits the three stakeholders - caregiver, care recipients and the care service provider



Caregiver Health

- Low for wife
- Higher at low level for husband and parents for daughters
- Medium for son attending to parents



Burden experienced by Family Caregivers

Sons and daughters - High Husband - Medium Wife - Lowest




Caring involves personal sacrifices and stresses though its significance vary according to the personal circumstances and the capacity to cope
